**FALL 2024 MYSTERY SHIRT SWEEPSTAKES**  
**OFFICIAL RULES**

**1. NO PURCHASE NECESSARY TO ENTER OR WIN.**

2. **ELIGIBILITY:** Open to residents of the 50 United States and D.C., 21 years of age or older as of September 12, 2024, and who are legally eligible to acquire and possess the prize(s) in their state of residency. No person that, during the pendency of this sweepstakes and prior to its termination, is or otherwise becomes prohibited from possessing, acquiring, or transporting firearms or ammunition is eligible to enter or win this Sweepstakes. Winner must sign and return any required affidavit(s) and other required documents within 10 days of notification.
