**AMMUNITION:** For optimal performance with Q silencers and firearms it is recommended that you always use quality, factory loaded ammunition. Each ammunition type will have a different performance based on the projectile velocity, barrel length of the firearm, and shooting conditions.

**SILENCERS:** Q silencers are designed to reduce the sound pressure of its compatible cartridges to below 140dB, which is the OSHA standard for "Hearing Safe" sound pressures for Impulse or Impact noise. Hearing damage is cumulative - exposure to longer duration noise may require the use of additional hearing protection to maintain a "Hearing Safe" level, even if the noise level is below 140dB.
